ARTICLE I. NAME OF ORGANIZATION

The organization shall be called Triton Aviation at UC San Diego.

ARTICLE II. STATEMENT OF PURPOSE

Triton Aviation aims to be a community for flight simulation enthusiasts and aviation enthusiasts at the University of California, San Diego. Flight simulation, being conventionally expensive, makes it hard to access. We plan to have events wherein students would be able to experience flight simulators at no cost.

ARTICLE III. NONPROFIT STATEMENT

Triton Aviation at UC San Diego is a non-profit student organization.

ARTICLE IV. REQUIREMENTS FOR MEMBERSHIP

No fees or dues are required for membership whatsoever, and membership is available for anyone interested in flight simulations.

ARTICLE IV. SECTION ONE. NON-DISCRIMINATION POLICY

Triton Aviation prohibits any act of discrimination in its operations. Any act of discrimination must be reported to any principal member, and if proven true, the offender's membership will be terminated and/or reported to officials.

Triton Aviation recognizes that flight simulation is a very male-dominated hobby worldwide, and it is committed to minimizing the risks associated with this demographic imbalance. We strictly prohibit any form of gender-based discrimination and strive to foster a welcoming environment for all gender identities.

ARTICLE V. FREQUENCY OF ORGANIZATION MEETINGS

Triton Aviation will host member meetings once per three (3) weeks and leadership meetings once per two (2) weeks. None of these meetings are required and minutes are not taken. Meeting time and location will be different each meeting and will be communicated with members through email.

ARTICLE VI. QUALIFICATIONS FOR HOLDING OFFICE AND METHODS OF SELECTING AND REPLACING OFFICERS

Only registered UC San Diego students may hold office in the organization. Only registered UC San Diego students may vote in elections for the selection of the organization's officers.

As of fall 2024, there are 3 officers leading Triton Aviation. Although there is not an executive committee, the officers will meet regularly to discuss important issues and make decisions as a group. Elections will start when current officers deem that it is necessary.

Demands of the club are evaluated monthly at the staff meeting and the decision of selection of officers are discussed at the first few weeks of each year. Once the decision of selection is made, interested members have two (2) weeks since the announcement of selection to contact any principal member. Selected officers will start their position at the first staff meeting after the announcement.

To be eligible for office, one must be a registered member of Triton Aviation and have shown strong interest in the club.
